

This Master Lease Agreement is entered into as of the date set forth below by and between BALBOA CAPITAL CORPORATION ("Lessor") and Leasee with reference to the following facts.

From time to time Lessee desires to lease various items of personal property from Lessor, and Lessor and Lesso B.

"Master Lease" shall mean this agreement, "Lease" shall mean each Schedule entered into between Lease and Lessee pursuant to this Master Lease.

#### NOW THEREFORE, Lessor and Lessee agree as follows:

## TERMS AND CONDITIONS OF LEASE

- 1. LEASE. Lessor shall lease to Leasee and Lessee shall lease from Lessor the items of equipment and other personal property (hereinafter, together with all replacements, repairs, substitutions, additions, accessions and accessories therefor and/or thereto, called the "Equipment") described in the lease Schedule(s) (hereinafter individually called a "Schedule" and collectively called "Schedules") now or hereafter from time to time executed by Lessor and Lessee and made a part hereof, all upon the terms and conditions hereinafter set forth as supplemented with respect to each item of Equipment by
- TERM. Each Schedule shall become effective upon acceptance by Lessor by signing and dating each Schedule and the term for any Schedule(s) shall commence on the day that the leased property has been delivered to and is usable by Lessee ("Commoncement Date"). Lessee shall at its sole discretion select the type, quantity and supplier of each item of Equipment. Lesses shall not be liable to Lessee for any failure or delay in obtaining delivery of any Equipment. Upon delivery of any Equipment to Lessee, Lessee shall forthwith inspect such Equipment and, within ten (10) days of delivery of the Equipment. Lessee shall execute and deliver to Lesser and delivery of an Delivery and Acceptance Certificate, in form and substance ratio actors to Lessee's execution and delivery of a Delivery and Acceptance Certificate covering any Equipment shall conclusively establish, as between Lessor and Lessoe, that such Equipment has been unconditionally accepted by Lessee for all purpose of this Lense.

With respect to each Lease, if for any reason the Equipment has not been delivered, installed and accepted by Lease within sixty (60) days after it is ordered by Leaser, or if Lesser fails to accept the Equipment and execute a Delivery and Acceptance Certificate within (10) days following delivery of the Equipment. Leasor may at Leasor's option, terminate Leasor's obligations under such Lease and tessee shall, on demand of Lessor, pay Lessor all amounts paid or owing by Leasor with respect to the purchase of such Equipment and indemnify and hold Leasor harmless from any and all Habilities, claims, costs and expenses to the manufacturer or supplier/vendor of the Equipment or any party, arising out of or relating to the Equipment or the Lease. Upon payment of such amounts, Leasor shall release, cernise and quit claim such Equipment to Leasee AS IS, WHERE IS, AND WITHOUT WARRANTY EXPRESSED OR IMPLIED BY LESSOR AS TO ANY MATTER WHATSOEVER. Lessee thall upon such payment by subpropagate in Leasor's object for the contractions of such amounts of such amounts of such amounts. shall upon such payment be subrogated to Lessor's claim. If any, against the manufacturer or supplier/vendor of such Equipment.

Lessee agrees that its remedies, should it find fault with any of the Equipment, shall be and are solely against the manufacturer and/or supplier/vendor of such Equipment. The base term of each Lesse shall commence on the first day of the month following the Commencement Date and terminate upon the expiration of the number of months specified in each Schedule. Each Lesse may be terminated by Lessee at the end of the base term if one hundred twenty (120) days prior to the end of the base term, written notice of such termination is delivered to Lessor (by certified mail). Each Lesse may be terminated by Lessor at the end of the base term if at least sixty (60) days prior to the end of the base term, written notice of such termination is delivered to Lessee (by certified mail). Otherwise the term of each lesse shall automatically be extended for six months following the end of the initial base term at the rest stated on the respective Schedule(s), and shall renew thereafter for successive three month periods until notice of termination is provided by Lessee. During the initial extension period, Lessoe, at its sole uption, may terminate each lesse upon ninety (50) days prior written notice to Lessee (by certified mail). After the initial extension period, each Lease may be terminated by either Lesser or Lessee at the end of any calendar month, provided that ninety (90) days prior written notice of such termination is delivered to the other party (by certified mail).

- 3. RENT. The monthly rent payable with respect to any Schedule(s) shall be the amount shown on such Schedule(s). Lessee shall pay to Lessor the monthly rent for each schedule, in advance, for each month or any part thereof that each Lesse is in effect. The first such payment, with respect to any schedule, shall be made on the first day of the month following the Commencement Date. A prorata portion of the rental charges based on a daily rental of one—thirtieth (1/30) of the aggregated average of the monthly rentals calculated from the Commencement Date to the end of the month shall be due and payable at the Commencement Date. Installments of rent or personal property tax which are not paid within tex (10) days of their due date shall be subject to a late charge equal to ten persent (10%) of each such delayed payment. The late charge set forth in this contract shall apply only when permitted by law and, if not permitted by law, the late charges shall be calculated at the maximum rate permissible by law. In the event that a check or other instrument tendered for payment is dishonored, Lessor shall be entitled to a twenty-five dollar (\$25.00) fee. All rent shall be paid at the place of business of Lessor shown above or such other place as Lessor may designate by written notice to Lessee. Lessee agrees to pay taxes and reasonable fees, including but not limited to documentation fees, filling fees, oredit fees, equipment inspection fees, title fees, properly taxes, sales taxes, use taxes, business taxes and further agrees to pay twenty dollars (\$20.00) per collection call and one hundred dollars (\$100.00) per collection visit. Lessor may apply remittances received to unpaid rental installments and/or other charges on a due date basis, remittance received being applied to the oldest unpaid rental or charge.
- FINANCE LEASE STATUS. The parties agree that this Lease is a Finance Lease as defined by Section 10103(2)(7) of the California Uniform Commercial Code ("UCC"). Lessee acknowledges the following: (a) Lessor has not selected, manufactured, or supplied the Equipment; (b) Lessor acquired the Equipment or the right to possession and use of the Equipment in connection with the Lesse; (c) Lessee has received, reviewed and approved all written Supply Concrects (as defined by UCC Section 10103(a)(25)) covering the Equipment purchased from the Supplier (as defined by UCC Section 10103(a)(24)) thereof for lesse to Lessee on or before signing this Lesse Contract (as defined by UCC Section 10103(a)(12)); (d) Lessor has informed Lessee inwriting of the identity of the Supplier; (e) Lessor has informed Lessee that Lessor may have rights under the Supply Contract and that Lessee is to contact the Supplier for a description of any such rights, and; (f) Lessor provides no warranties or other rights with respect to the purchase of the Equipment and any and all rights Lessee has with respect to the purchase of the Equipment are solely against supplier, and Lessee may communicate at any time with the supplier prior to executing this Lease.
- DISCLAIMER OF LESSOR WARRANTIES. LESSEE ACKNOWLEDGES THAT THE EQUIPMENT TO BE LEASED HEREUNDER WILL BE OF A TYPE, DESIGN, SIZE. CAPACITY AND MANUFACTURER SELECTED BY LESSEE ACKNOWLEDGES THAT THE EQUIPMENT TO BE LEASED HEREUNDER WILL BE OF A TYPE, DESIGN, SIZE.

THIS IS A NET LEASE, AND ALL RENT AND ALL OTHER SUMS PAYABLE BY LESSEE HEREUNDER SHALL BE PAID UNCONDITIONALLY WHEN DUE WITHOUT ABATEMENT, DEDUCTION, COUNTERCLAIM OR SETOFF OF ANY NATURE INCLUDING WITHOUT LIMITATION ANY COUNTERCLAIM OR SETOFF ARISING OUT OF ANY PRESENT OR FUTURE CLAIM LESSEE MAY HAVE AGAINST LESSOR, OR ANY ASSIGNEE OF LESSOR OR THE MANUFACTURER OR SUPPLIER OF THI EQUIPMENT, OR ANY OTHER PARTY. - 7. COMMERCIAL RISK. Lessee bears all risk that the Equipment may become unusable for any reason, including without limitation, loss, theft, damage, destruction, defect.
  GOVERNMENTAL REGULATION, PROHIBITION, IMPRACTICABILITY OF USE, OBSOLESENCE, FAILURE TO OPERATE BY REASON OF THE CHANGE OF THE CENTURY OR COMMERCIAL FRUSTRATION. No inability to use the Equipment shall result in the termination of any Lease or relieve Lessee from any of its obligations under any Lease.
- S. USE AND LOCATION. Lessee shall use the Equipment in a careful and proper manner and in compliance with all laws, ordinances, regulations and insurance policy conditions in any way relating to the possession, use or maintenance of the Equipment. Unless the Equipment is of a type normally used at more than one secasion (such as vehicular equipment, construction machinery or the like). Lessee shall not remove the equipment from the location designated in the applicable Schedule(s) without the prior written consent of Lessor. If an item of Equipment is of a type normally used at more than one location, Lessee shall not use the Equipment outside of the area designated in the applicable Schedule(s) without prior written approval of Lesson. - 9. OWNERSHIP. The Equipment is, and shall at all times be and remain, the sole and exclusive property of Lessor, and Lessee shall have no right, tide or interest therein or thereto except as expressly set forth in this Lesse. Plates, labels or other markings stating that the Equipment is owned by Lessor shall be affixed to or placed on the Equipment by Lessor or, at Lessor's request or if required by law, by Lessee at Lessee's expense, and Lessee shall keep the same in a prominent position thereon.
- 10. PERSONAL PROPERTY. The Equipment is, and shall at all times be and remain, personal property notwithstanding that it or any part thereof may now be or bereafter become, in any manner affixed or attached to, or embedded in, real property or my building thereon. Lessee agrees that it will furnish and record, at its own expense, such owners', mortgagees', landlords', or other disclaimers, waivers, or consent as may be necessary or reasonably requested by Lessor in order to give full effect to the intent and provisions of the preceding sentence.
- 11. MAINTENANCE AND REPAIRS. Lessee, at its own cost and expense, shall keep the Equipment in good repair, condition and working order and shall furnish any and all parts, mechanisms and devices required for such purpose. All such parts, mechanisms and devices affixed to any Equipment shall thereupon become the property of Lessor and subject to the terms and conditions of this Lease. Lessee shall modify the Equipment if required by any governmental authority or law and will make such modification known to Lessor by written notice to be delivered by certified mail.
- 12. ALTERATIONS. Without the prior written consent of Lessor, Lessee shall not make any alterations, additions or improvements to the Equipment. All additions and improvements of whatoever kind or nature made to the Equipment shall be made at Lessee's sole cost and expense and when made become the property of Lessor and subject to the terms and conditions of this Lense.
- 13. LESSOR'S INSPECTION. Lessor shall during normal business bours have the right to enter into and upon any premises where any Equipment may be located for the purpose of inspecting such Equipment or observing its use. Lessee shall, whenever requested by Lessor, advise Lessor of the exact location of any and all items of Equipment.
- LOSS, THEFT AND DAMAGE. Lessee shall at all times after signing this Lesse bear the entire risk of loss, theft, damage or destruction of the Equipment from any cause whatsoever, and no loss, theft, damage or destruction of the Equipment shall relieve Lessee of the obligation to pay sent or to comply with any other obligation under this Lesse. In the event of damage to any part of the Equipment, Lessees shall place sante in good repair at Lessee's expense. Leasee shall provide and maintain insurance against loss, theft, damage or destruction of the Equipment in an amount of not less than the Stipulated Loss Value of the Equipment, with loss payable to Leasor, Leasee shall also provide and maintain comprehensive general all risk liability insurance including but not limited to product liability coverage, insuring Lessor and Lessee, with severability of interest endorsement, or its equivalent, against any and all loss and liability for all damages, either to persons or property or otherwise, which might result leason and assigns shall not be invalidated by any act, emission, or neglect of Lessee and cannot be cancelled without thirty (30) days prior written notice to Lessor. In case of failure of Lessee to procure or maintain proper insurance or to pay such fees, assessments, duties, charges and taxes or to keep any item of Equipment free and clear of all levies, liens and encumbrances or in good repair, condition and working order, all at herein before provided, Lessor shall have the right, but not the obligation, without notice to or demand upon Lessee, and without releasing Lessee from any obligation herein before specified, to effect and pay for such insurance or to pay such fees, assessments, duties, charges and taxes or to keep such Equipment in good repair, condition and working order, as the case may be, and to pay, purchase, contest or compromise any encumbrance, charge or lien which in the sole judgment of Lessor appears to affect such Equipment, and in exercising any such right, to incur any liability and expend whatever amounts in its absolute discretion it may deem necessary therefor. Lessee will at its sole cost and expense deliver the Equipment (in the same condition as when delivered in Lessee, reasonable wear and tear resulting from authorized use thereof alone excepted to Lessor's premises set forth above or any place designated by Lessor in writing, for such disposition as Lessor may determine. No such return shall constitute termination of this Lease unless Lessor shall

- 19. COMMITMENT FEE. Unless otherwise defineated on the respective Schedule(s), the amount, if any, which Lessee has deposited with Lesser as set forth in any Schedule shall constitute partial security for Lessee's obligations under this Lesse. This commitment fee shall not be refunded, but upon Lessor's acceptance of Lessee's offer to enter into any Lesse, may at Lessee's option, be applied at any time in partial satisfaction of any obligation of Lessee which may be in default, although the making of such deposit shall not excuse Lessee from any such obligation and such application of the amount shall only release Lessee from the obligation pro tanto. Lessee acknowledges that Lessor shall deposit this commitment fee and that the deposit of this commitment fee shall not be construed as an approval and/or acceptance any Lesse and shall not become binding upon Lessor until approval and acceptance by Balboa Capital Corporation's Finance Commitment.
- 20. ASSIGNMENT BY LESSOR. Lessor may, at any time, with or without notice to Lessee, mortgage, grant a security interest in, or otherwise transfer, sell or assign this Lease or any Equipment or any rentals or other amounts due or to become due hereunder, Lessee with Lessor and any such assignee (including any assignee to which such rights have been assigneed by a prior assignee) that, upon receipt by Lessee from Lesser or such assignee of notice in writing of any such assignment, Lessee will, make all further payments due or to become due hereunder directly to such assignee at the address specified in such notice of assignment and will recognize such assignee as the person entitled to excrede all other rights of Lessor hereunder. Upon any default by the Lessee in the payment and performance of its obligations under any Master Lease Agreements and Lease Schedules with Lessor, the liabilities and obligations of the undersigned hercunder shall, at the option of Lessor, become forthwith due and payable to Lessor without demand or notice of any nature, all of which are expressly waived by the undersigned.

This Guaranty is executed as an instrument under seal, and all acts and transactions hereunder, and the rights and obligations of the parties hereto shall be governed, construed and interpreted according to the laws of the State of California. The undersigned hereby expressly waives the right to a trial by jury.
