This prestigious and coveted designation is designed to identify and recognize those individuals within the leasing profession who have demonstrated, through experience, testing and conduct, their competency in leasing. The letters "CLFP" behind their name represents a visible recognition of this professional achievement and status. This is the first step in reaching that designation and obtaining the CLFP Associate designation.

CLFP REQUIREMENTS AND ELIGIBILITY

- 1. A minimum three years of verifiable equipment leasing and financing experience.
- 2. Acceptable public records background check
- 3. Completion of the required application to become a Certified Lease & Finance Professional. *
- 4. Pledge, in writing, to adhere to the Standards of Professional Conduct.
- 5. Acceptable character ability and reputation.
- 6. Successfully complete the Certified Lease & Finance Professional examination.
- * Candidates must have their applications submitted at least 4 weeks prior to the scheduled examination date.

STANDARDS OF PROFESSIONAL CONDUCT

- A Certified Lease & Finance Professional will always strive to conduct all business dealings in an honest, ethical, and professional manner.
- A Certified Lease & Finance Professional will respect ownership of funds delivered as advanced fees or security deposits and will treat in a fiduciary capacity all funds received in that capacity.
- A Certified Lease & Finance Professional will strive to constantly gain additional education to improve his/her professional competency and will work to promote education and integrity within the leasing industry.
- A Certified Lease & Finance Professional will never knowingly make false or misleading statements to his/her employer, employees, customers, vendors, brokers or funding sources.
- A Certified Lease & Finance Professional will never be involved in fraudulent activities.
- A Certified Lease & Finance Professional will act in a leadership role in the industry and always be held to the highest standards of conduct applicable to the industry.
