Upon consideration of the application of Shaw Gussis Fishman Glantz Wolfson & Towbin ("Shaw Gussis") as special counsel to David Leibowitz, not personally, but as chapter 7 trustee for the estate of IFC Credit Corporation ("IFC") requesting the entry of an order pursuant to 11 U.S.C. §§ 330 and 331 and FED. R. BANKR. P. 2002(a)(6), 2002(i), 2016(a) and 9007 for the allowance and payment of \$664,464.55 in interim compensation for 1,953.2 hours of professional services rendered by Shaw Gussis and \$12,960.21 in expenses incident to those services between November 1, 2009 and June 30, 2010 (the "Application Period"); it appearing that there is good cause to grant the relief requested; and, there being no objection to the relief requested; it is therefore ORDERED that:

- 1. The Application is granted.
- 2. Shaw Gussis is allowed compensation for actual and necessary legal services provided to the Trustee in the amount of \$664,464.55 (the "Second Interim Compensation") and reimbursement of actual and necessary expenses advanced for the benefit of the Trustee in the

amount of \$12,960.21 (the "Second Interim Allowed Expenses") (collectively, the "Second Interim Award").

- 3. The Trustee is authorized, as Estate funds become available, to pay Shaw Gussis the Second Interim Award in the amount of \$677,424.76.
- 4. The shortened and limited notice of the hearing on the Application is excused for cause shown.
