GOVERNMENT'S NOTICE OF RELATED CASE

Now comes the United States of America, by and through Steven M. Dettelbach, United States Attorney, and Christian H. Stickan and Robert J. Patton, Assistant United States Attorneys, and files this Notice of Related Case. Pursuant to Local Criminal Rule 57.9(b)(3), Case Number 11-CR-003 may be considered related to Case No. 10-CR-134, assigned to the Honorable Judge Jack Zouhary.

Although Rule 57.9 provides for reassignment of related cases, the rule itself does not articulate a governing standard. Rather, when filing a criminal case, the United States Attorney's Office is required "in any case which is, or might be considered, related to another case, file a motion/notice with both District Judges advising the Court of the relationship. A new violation resulting in a federal indictment or information may be considered related to the previously filed case." Id. Pursuant to that rule, the government is hereby providing this notice. This newly filed indictment involves the same scheme and conspiracy as in Case No. 10-CR-134.

Due to the fact that there is some relationship between the charges in these cases since the same scheme is charged in both cases, the government believes that these should be considered as related cases under Rule 57.9(b).
