

Mr. Trebels has been avoiding service of process. On 07-24-2009 at 8:00 am a late 2000 model year Black Lexis SUV entered the residence driveway, as I drove up to the Trebels house and approached the garage door the driver of the SUV ignored my calling out "hello please open the door". The driver would not come to the front door of the house as I repeatedly rang bell and knocked. On 07-28-2009 I returned to the residence and identified two vehicles in the driveway. IL plate A44 8998 and IL plate 247 8646. I rang the bell and knocked on the door at 7:00 pm after sitting on the street from 5:10 pm to 7:10 pm. No answer that evening. On 07-29-2009 I returned to the house at 6:00 am waited down the street on ***** approx one qtr. mile. The far left (West) garage door began to open at 7:05 am. I immediately drove down the street and parked my car along side the north entrance of the horseshoe driveway. At my arrival a Black BMW 7 series 4 door sedan with the vanity plate RDI 65, was approximately 10-12 feet away from my vehicle. I exited my car with the legal papers in my left hand and raised the papers over my head and said in a loud voice "I'm here to serve you papers". As I walked in front of my car and approached the driver side of the BMW, Mr. Trebels hit the gas and recklessly sped out of his driveway nearly hitting my vehicle and a large rock along the side of the road at the entrance. His speed was in excess of 45-55 mph as he drove away down the residential street and failed to come to a complete stop at the 4 way stop intersection north of his home. I dropped the papers near the garage on the driveway. I yelled out to Mr. Trebels as he drove past me "You've Been Served".
