This is no more evident than in the amount of video testimonials we receive, many of which are featured here." [Ex. A.] The site has links to approximately 45 videos, categorized by industry. On the videos the customer typically identifies him or herself and his or her business, often with the company logo displayed. [Ex. A.]
- 5. One testimonial video found on Balboa Capital's website from Frank Ann of Nostrum Laboratories specifically mentions defendant Don Hansen by name twice when Mr. Ann recounts his positive experiences with Balboa Capital. Mr. Ann also mentions dealing with many finance companies over the last five years. [Ex. A.]
- 6. Another testimonial video found on Balboa Capital's website from Ed Ho of AdTech Optics specifically mentions defendant Dennis Odiorne as Mr. Ho discusses the professionalism he experienced when financing through Balboa Capital. [Ex. A.]
