26 After consideration of the moving and any opposition papers filed regarding Plaintiff's

1 Application for a Preliminary Injunction, the case file, and oral argument presented before the
2 Court, and good cause appearing therefore,

3 **IT IS HEREBY ORDERED:**

4 1. A Preliminary Injunction enjoining Regents Capital Corporation, and all
5 Defendants and all persons acting or claiming to act under, in concert with, or for
6 Defendants, or any of them from engaging in any solicitation of companies who
7 submitted an application to BALBOA that Defendants reviewed while at
8 BALBOA is **GRANTED**.

9 2. A Preliminary Injunction enjoining Regents Capital Corporation, and all
10 Defendants and all persons acting or claiming to act under, in concert with, or for
11 Defendants, or any of them from using, copying, dealing with, disclosing, trading,
12 and otherwise exploiting or misappropriating BALBOA's confidential
13 information including its customer list and customer files is **GRANTED**;

14 3. A Preliminary Injunction enjoining Regents Capital Corporation, and all
15 Defendants and all persons acting or claiming to act under, in concert with, or for
16 Defendants, or any of them from destroying any documents or files of any kind,
17 actively or passively, whether in written or electronic form, that relate in any way
18 to BALBOA's Confidential Information, and/or BALBOAs actual or prospective
19 customers is **GRANTED**; and

20 4. A Preliminary Injunction compelling Regents Capital Corporation, and all
21 Defendants and all persons acting or claiming to act under, in concert with, or for
22 Defendants, or any of them to return all of BALBOA's confidential information
23 in their custody, possession, or control to BALBOA is **GRANTED**.
