**CASE MANAGEMENT ORDER**

Pursuant to the Court's April 11, 2008 Memorandum Opinion, the Court orders the following:

- The Trustee shall file an amended complaint by May 26, 2008. Responses are due June 16, 2008. Responses may assert any Rule 8, 9, 12(e), or 12(f) objections that are unresolved by the Trustee's amended complaint.
- Any Lender or other "party in interest" may object to proofs of claim filed in Today's Destiny's bankruptcy estate. Objections must be filed by May 12, 2008. Failure to object to a proof of claim will not estop any interested party from contesting its proportionate responsibility or personal liability arising from Today's Destiny's liability on the proof of claim.
- Pursuant to the Court's July 6, 2007 Memorandum Opinion and Order on Motions to Intervene, and the Court's April 11, 2008 Memorandum Opinion, the Court authorizes intervention in this adversary proceeding of certain parties. "Exhibit A," attached to this order, lists parties that may intervene against Lender Defendants. "Exhibit B," attached to this order, lists parties that may intervene against non-Lender Defendants.
- Parties granted intervention and who wish to assert causes of action in this adversary proceeding must file a complaint by May 12, 2008. Defendants must respond by June 2, 2008 and may assert any applicable defense.
